c. Justification:

- i. There is a tendency of students joining M Tech (CSE) as full time candidates and after completion of First Year (i.e post completion of theory papers), the student converts their registration as Part Time and resume their duty which affects the progress of Major project Work.
- ii. In- Service students joining M Tech (CSE) on study leave must furnish Service

Relieve Order from their employer for the entire duration of their M Tech Programme.

Item No.IX Introduction of Elective "Advanced Cryptography and Network Security" for M Tech student from Academic Session 2014-15.

Security has always been an integral part of any information system. Introduction of the subject in M Tech as an elective would highlight its importance on Advance Computer Networks and Distributed systems which are the core subjects of the curriculum. From the research point of view it is an important issue to be included, understood and analyzed. Many students have keenly interested on working with security related problems for their major project. Thus, the subject would equip the student with the basic security related concepts, services and mechanism and would also cater with the latest trends and information.

Item No. XI Introduction of Environmental Science for B Tech Students

B Tech Environmental Science syllabus of SMIT has been compared with UGC guidelines, and the observations and finding are noted in following points: -

SMIT is following the syllabus as prescribed by UGC. The existing syllabus consists of all the seven units of model as prescribed by University Grants Commission given as below.

- a) Definition, scope, application and significance of Environmental Science for future engineers
- b) Population and environment relationship
- c) Natural resources of earth Non -renewal and renewable
- d) Ecosystem structure & function
- e) Biodiversity and conservation
- f) Environmental Pollution aspects
- g) Social & global issues like global warming, stratospheric ozone depletion, acid rain etc.

However, the credit of Environmental Science is kept 2 in SMIT, whereas it is recommended as 4 credit course in UGC guidelines.

Currently there is no provision of field work in Environment Science syllabus as recommended by UGC (25 marks out of 100 marks evaluation).

Item No. XII Discontinuation of course on Academic Grounds

As per the Not Fit for Technical Education (NFTE) rule for Engineering, a student will be declared NFTE, if he fails to get promotion from 1st to 2nd year within two years of admission or if he fails to complete the course within eight years (i.e double the normal course duration).

However, no such rules are framed for other courses.

It is proposed to have the following rules to disallow a student to pursue a course on academic grounds:-

- i) For BCA, BBA, MCA
 - A student should earn minimum number of credits for promotion to 2nd year within two years of admission.
 - A student should complete the course within double the normal course duration.

- ii) For MBA & MSc
 - A student should complete the course within double the normal course duration.

Item No. XV Approval for Open Electives proposed by Mathematics Department on (i) Graph Theory, Algorithms and Applications and (ii) Operations Research

Decision: Approved. Examples may be selected from applied areas of engineering and management. Operation Research can be floated as an elective to the engineering and other courses who do not have these subjects in their curriculum after seeking feedback from the concerned departments.

Item No. XVI Closure of Extra semester of final year students:

- a) As the parallel semesters are introduced wef. 2012-13 batch, the options for conducting extra semester classes/examinations for final year may be continued till 2012-13 batch passes out in June 2016.
- b) The same may be notified for the knowledge of the students of 2013-14 and later.
- c) Extra-semester if permitted for final year students can be conducted during the month of August/September. This will avoid the presence of senior students in the campus during the admission period. Results of final year students can be declared by June. Convocation can be scheduled in the month of October/November by which time the results of extra-semester will be available and the final list of passing out students ready.

Item No. XVIII Constitution of DRC for each individual Ph.D. work instead of a common DPRC

- a) For systematic reviews of Ph.D. work, separate Doctoral Review Committee (DRC) for each scholar may be constituted with experts from the relevant research areas chosen from within/outside the department.
- b) DRC may consist of 3 members with additional members of guide/co-guide as invitees and the Dean (R & D) as the ex-officio member.
- c) DRC shall report to the Chairman, IRPEC/Director, SMIT.

Decision: This is already in practice. Instead of Doctoral Review Committee (DRC) the said committee is known as Research Progress Committee (RPC) in the university PhD rules. The RPC will have two members from the concerned department, one member from another department knowledgeable in the subject concerned. Director and Dean R&D will be present for all RPC proceedings. It is advisable to include one external expert of the subject also.

Item No. XIX Minimum Cut off marks for passing a theory subject.

It is proposed to keep the minimum cut off for passing a passing a theory subject at 35 out of 100 (inclusive of both in-sem and end sem marks) subject to the condition that the student has appeared in both examinations. This shall supersede the decision of 44th ASM (Item No VIII) dated 14 July 2014 and letter No SMU/Reg/2014-282 Dated 20 May 2014.

Decision: Ratified. Further the pass marks and award of grades for lab will be reverted to that followed for 2012 and earlier batches. The minimum pass marks will continue to be between 35 and 50 overall depending upon the class average as has been the practice.

Students obtaining 60% and above up to less than 70% shall be declared as passed with first class. Students obtaining 70% and above shall be declared as passed with distinction. A mention of the specialty of the students dissertation work will be made in the university certificate.

Manipal University, **Manipal**: - 75% and above – First Class with Distinction, 65% and above but less than 75% - First Class, 55% and above but less than 65% - Second Class, Less than 55% but pass – Pass Class.

Proposal: - Students obtaining 50% and above upto less than 55% shall be declared as passed. Students obtaining 55% and above up to less than 60% shall be declared as passed with second class. Students obtaining 60% and above upto less than 75% shall be declared as passed with first class. Students obtaining 75% and above shall be declared as passed first class with distinction. A mention of the specialty of the students dissertation work will be made in the university certificate.

Item No. XXIII Change in Examination Pattern

The University has issued a notification vide letter no. SMU/Reg. Acad/2014 - 160 dated 12^{th} Nov, 2014 for Change in Examination pattern. The same is placed before the Senate for ratification.

The DEB/UGC Expert Committee which visited the University on $23^{\rm rd}$ - $24^{\rm th}$ May has recommended that the present evaluation system of the University fails to assess learning potential and analytical skill of the learner. It was further recommended that SMU must follow descriptive test & question may carry 2/5/10/12/16 for the term end examinations. The 40% pass marks should be applicable to both internal assignments and Term end examinations.

The above recommendations of the Committee limits the scope of the MCQ (Multiple Choice questions) while giving more weightage to descriptive questions. In view of the above, the following changes are hereby introduced with effect from the Academic Session July 2015.

- 1. The maximum marks for each paper should be 100 marks irrespective of the credits and would comprise of 70 marks for Term-end examination and 30 marks for Internal assessment.
- 2. The Term-end examination shall be of 3(Three) hours duration and may consist of 8 questions with following weightage, namely 2/5/10 marks. Each paper will consist of 3 sections A, B and C. Section A will be MCQ with 10 parts, each carrying 2 marks which amounts to 30% of the Term-end examination. Section B will consist of 4 questions, each carrying 5 marks, all of these will be descriptive questions. Section C will have 3 questions of 10 marks each. Thus the total of Section A, B & C becomes 70 marks.
- 3. Internal assignment will carry 30 marks and may consist of 6 questions of 5 marks each. Question should be framed in such a way that it covers the entire syllabus.

With the adoption of the above, the QP pattern for Term-end examination may be as below:-

Pattern - 2/4 credit paper - Total 70 marks (3 hours paper)

Part -B [4 x 5 marks=20 marks]: Descriptive Type

This shall supersede the decision of 44th ASM (Item No VIII) dated 14th July 2014 and letter No. SMU/Reg/2014-82 Dated 20 May 2014.

Further, the pass marks and award of grades for lab will be reverted to that followed for 2012 and earlier batches. The minimum pass marks will continue to be between 35 and 50 overall depending upon the class average as has been the practice.

The above regulation may be modified as given below:

The minimum Cut Off marks for passing a theory and a laboratory subject: The minimum cut off marks for passing a theory subject will be at 35 out of 100 (inclusive of both in-sem and end sem marks) subject to the condition that the student has appeared in both examinations. The minimum pass marks will be between 35 and 45 overall depending upon the class average as has been the practice.

For the laboratory subjects, the minimum pass marks will be between 35 and 50 (inclusive of both in-sem and end sem marks) subject to the condition that the student has appeared in both examinations, as has been the practice.

In addition, a student has to obtain the minimum cutoff for E-grade in theory and laboratory subjects respectively.

Decision: No need for separate notification. The notification SMU/Reg.Acad/2015-50 had restored the earlier practice for minimum cutoff for passing theory and practical. The earlier rules already provide for the minimum cut off between 35 to 45 for theory and 35 to 50 for practical based on class average.

- ii. Having both odd semester papers and even semester papers during supplementary examination the duration of examination becomes quite long. This time the duration is 16 July to 10 August 2015. Publishing the result and getting promotion list at the end of even semester after supplementary exam takes some times that goes to the next semester. When Makeup exam was not there in SMIT, those days Supplementary exam used to be conducted for both even and odd semester papers.

2) Duration / Commencement of the course

The Master of Nursing course is of two years duration. Tentative date for commencement of the course is 1st September, 2016 provided INC, WBNC, State Govt. and SMU approve the proposal.

3) Admission capacity

It is proposed to have a total intake of 25 candidates per year divided into five specialties - Medical-Surgical Nursing, Child Health Nursing, Mental Health Nursing, OBG Nursing & Community Health Nursing. Five seats will be allocated for each specialty.

4) Syllabus

The syllabus prescribed by Indian Nursing Council will be followed.

During establishment of this course it was well understood that the actual admission capacity is limited to 25 only as this course usually availed by the working GNM staff nurses who require support of sponsorships and in instant case sponsorships were available mainly from Sikkim Govt. and CRH. Outside candidates without sponsorship and usually being married find it difficult to leave behind the family and join the course. Still SMON went ahead with an admission capacity of fifty

because the INC minimum norm was for fifty candidates at that time. The number of sponsorship in last 4 years against the quota of seats is given below:
